## INTRODUCTION

### WHY A FOUNDATION FOR A “GREATER MEDITERRANEAN”?

1. The Mediterranean is an ancient geographic and political space, within which are found the needs for inter-cultural dialogue, peace, integration between innovation and tradition, and individual rights and social solidarity. The Mediterranean has long been fraught with tensions, crisis and conflicts that have torn the fabric of an otherwise peaceful and prosperous cohabitation.
2. The risk of a schism between those who believe in dialogue and those who favour a ‘clash of civilisations’ mandate increased engagement of governments and calls from civil society to promote a *coalition of shared values and interests*. More than ever, people of the Mediterranean have to define a strategy as direct expressions of the needs of their individual real needs. In the increasingly worrying international scene, the *Fondazione Mediterraneo* remains a player on the side of the forces of dialogue and reason. The real enemy, together with a sense of resignation, is the empty complacency exhibited by those who anaesthetize (or address the surface or address the symptoms of) the problem, hoping to hide reality.
3. Until now, numerous initiatives undertaken for the pacification and the development of the area have produced only partial and inadequate progress. The feeling of hope that the region experienced with the Euro-Mediterranean Partnership (activated by the European Union in 1995 as part of the Barcelona Process) and with other initiatives today are in a stalemate. This institutional slowing down (of each country and of the European Union) is worsened by a worrisome international context.
4. Therefore, the *Fondazione Mediterraneo* – remaining aware of the risks of altering structure and of marginalising the Mediterranean region – pledges itself to the creation of a **Greater Mediterranean**, with respect to the great civilisations of the past. This new approach will permit not create artificial barriers in the Arabic world, separating the Mediterranean countries from those of the Gulf.
5. Achieving a greater trust requires extending the dialogue from within the Greater Mediterranean so that it realises its destiny and defeats fear, distrust and hatred, thus wiping out the sources that nourish violence and terrorism.

The *Fondazione Mediterraneo* is an international non-profit Organisation of Social Utility (Onlus), which includes specialists and internationally recognised scholars on the Mediterranean, politicians with international and diplomatic experience, and who have been involved in Mediterranean affairs.

## **THE MISSION**

The *Fondazione* is dedicated to the realisation of a Greater Mediterranean, a concept both historical and strategic. It works in cooperation with the countries of the Middle East, the Gulf and the Black Sea.

The *Fondazione* bases its actions on the principles of equality, sovereignty, and dignity of peoples. It works in respect of pluralism and cultural diversity.

It is an organization that is free from bureaucracy and in which every resource is invested directly in the field: the great number of partnership accords signed, and of partnerships with civil society and with institutions active in different projects are indications of the high impact reached and of the concrete results achieved.

## **THE STRATEGY**

The *Fondazione*:

- develops dialogue between society and cultures in order to affirm fundamental rights (civil and political freedom; and social, cultural and economic rights), democracy and justice pursuing ethical values and reciprocal morale of respect and of exploitation of the differences;
- is a tool for researching solutions to the problems that threaten peace through strategies of co-existence;
- is a means of cohesion in reaching a common management of the Greater Mediterranean, also working in coordination with the European Union's Euro-Mediterranean policies of the (the Barcelona Process, the Politics of Neighbours, etc.)
- facilitates the participation of civil society and institutional actors through networks, platforms, forums and other modes of communication encouraging partnerships in order to avoid duplication and consequent waste of resources. Therefore, the *Fondazione* also supports and develops already-existing organisms and activities, maximizing the effective use of financial and human resources and thus, consequently, results.

## **GUIDELINES 2006-2010**

1. The *Fondazione Mediterraneo* has as its main objective the institution of a *Coalition of Shared Values and Interests* among the countries which, through the centuries, have acted around the Mediterranean – such as the Hellenic, Roman, Byzantine, and Islamic cultures – and which today, in continuing their social and cultural reciprocal influences, represent the area of the “Greater Mediterranean.”
2. The Coalition acts on the premise of developing models and programmes for cultural and material growth within the region, based on the concepts of equal dignity and mutual respect among different cultural identities – acknowledging that these peoples have their own principles and values, but at the same time must be open to exchange and discussion.
3. The reconciliation in the “Greater Mediterranean” needs a search for *Solidarity in Development*. Young people must receive education and professional training in order to reduce obstacles to their personal development.

## **THE PLAN OF ACTION**

The Fondazione's organization is flexible and dynamic. There is a high-level, permanent collaboration for planning and coordinating programs. There are technical support teams for publications, multimedia products, meeting organization, conferences, workshops and communication. Through branch offices in several countries and several organizational networks, the Fondazione is developing a work plan to accomplish the following:

1. *Activities of network the branch offices of the Fondazione*
2. *Participation in the programs of the network to which the Fondazione belongs*
3. *Technical coordination-organizational of the main office*
4. *Coordination of the Maison de la Méditerranée*
5. *Management of the database*
6. *Management of the web site and portals*
7. *Management of the press bureau and of press reviews*
8. *Management of the library*
9. *Management of the spaces for lectures, seminars, meetings, workshop, shows and varied events of the headquarters/main office*
10. *Actions for international visibility*
11. *Construction of relations and institutional engagement with countries, institutions and associations of the Greater Mediterranean*
12. *Missions in the countries of the Greater Mediterranean and elsewhere*
13. *Organizations of meetings of high political cultural and scientific impact, with representatives of the states of the Greater Mediterranean (heads of state and government; ministers; ambassadors; presidents of regions, provinces and local community; university rectors, etc.)*
14. *Organization of the "Mediterranean Award".*
15. *Activities of training and of research.*
16. *Publications of the Fondazione.*

Moreover, the *FONDAZIONE* is developing the following actions:

a – the direction of events, regarding initiatives conceived, realised and organised directly by the *Fondazione* (prizes, publications, advanced training programmes, workshops, seminars, lectures, concerts, shows, etc.)

b – The co-organisation of events, together with either partners within or of outside the *Fondazione's* networks or of other networks to which the *Fondazione* belongs.

c – The support of events organised from outside of either partners within or of outside the *Fondazione's* networks or of other networks to which the *Fondazione* belongs.

d – The accomplishment of broad projects, both autonomous in form and in response to local and international calls for proposals. Among the projects realised by the *Fondazione* are: Cinemamed, Medina, Medpride, Intercultural Dialogue, Civil Forum Euromed, Master's training in complexity and human ecology, Euromedcafé, Medpeace, etc.

## ACTIVITIES 2006-2010

Between 2006 and 2010 the FONDAZIONE MEDITERRANEO wants to realize the following activities:

### **1 - The Forum “Greater Mediterranean”**

The *Fondazione* will hold annually, starting from November 2008, a political, social and economic “Greater Mediterranean Forum”, to outline a model for the Region based on political security. An in-depth analysis will be undertaken in preparation for the Forum to find ways and means on one side, to identify, prevent and contain factors sparking tensions and on the other to shed light on common interests. The Forum will namely focus on ***National Interests and Shared Security*** addressing the following issues:

- institutions and society
- media and communications
- culture and education
- economic and social cohesion

The final Forum, in May of 2010, will have the aim of laying down the bases recommending the creation of an Organisation of the States of the Greater Mediterranean. Following the works to the annual Forums, the *Fondazione* will hold a series of tailor-made workshops aimed at drawing up chapters on a geo-strategic concept paper for the Greater Mediterranean vis-à-vis the underlying effects which are being produced in the Region by the growing globalization trend.

### **2 - Publications**

The *Fondazione* will continue to document and inform on the *Greater Mediterranean* through newsletters, countries reports, thematic papers etc. Moreover the *Fondazione* wants to publish a biennial “Report on the Greater Mediterranean” as reference instrument for politicians, businessmen and experts in culture.

### **3 - Mediterranean Award**

Each year The *Fondazione* will continue to organize the business of presenting the Mediterranean Awards that will be given to outstanding contributors in art (**literature, art, creativity**) and civil society (**peace, democracy, institutions, information, diplomacy**) of the *Greater Mediterranean*.

### **4 - Euro-Mediterranean Award for the dialogue between cultures**

From 2006 the Mediterranean Award will be enriched by the creation of a new category called the Euro-Mediterranean Prize for Dialogue between Cultures. This prize will be awarded every year in conjunction with the Anna Lindh Euro-Mediterranean Foundation for Dialogue between Cultures, the newest institution created by the European Union in the area of the Euro-Mediterranean Partnership. The ALF consists of 35 networks in 25 countries members of the EU and in 10 countries of the Mediterranean Southern Shore. The FM, head of the Italian network, has agreed together with the national networks that, starting from 2006, the networks consisting of 650 organisms and belonging to 35 countries will nominate candidates and choose the recipients. Father Paolo Dall'Oglio, Monastery *Mar Musa* (Sirya), was awarded in 2006.

## **5 - Lectures Series**

### ***Mediterranean, Europe and Islam: Actors in the Dialogue***

The Fondazione will carry on a series of lectures on the programme "Mediterranean, Europe and Islam: Actors in the Dialogue" aiming to straighten the mutual understanding and cooperation among:

1. Countries on the southern shore and those on the northern shore of the Mediterranean.
2. European and Muslim communities inside and outside Europe.

## **6 - "Twinning" among Institutions, organizations and projects**

The Fondazione will continue to work in partnership with other countries in order to develop specific projects and "twinning" among other institutions of the Greater Mediterranean area.

## **7 - Concerts for the dialogue between cultures.**

After the success of the *First Euro-Mediterranean Concert for the Dialogue between Cultures*, organized in Cairo, Otranto, Naples, Rome, Cosenza, Luxemburg and Barcelona in 2005, the Fondazione will continue to organize each year a series of concerts on the theme "*Dialogue between Cultures*". In 2006 the *Second Concert* started in Otranto on December 31st and it took place also in Algiers, Luxemburg, Casablanca, Naples, Cosenza and Sivilla.

## **8 - Craft and Arts**

The Foundation will seek collaborations and synergies for the creation of training schools and the establishment of district museums in the city centres of the main cities of the Mediterranean with the aim of enhancing the appreciation of craft and arts.

## **9 - Communication and Information**

The Fondazione collaborates with ANSAMed (news agency for the Mediterranean), "Le Monde Diplomatique" and other newspapers of different Countries. The Fondazione deals with the planning, managing and maintenance of the following web pages:

## **10 - Community Service**

The Fondazione, collaborating with the association Expoitaly, has carried out projects for the National Community Service. These projects are called "*Mediterranean, a sea of peace*" and "Bibliopolis." The Fondazione is still working on the other programmes

## **11 - Master Degree on Community Management**

The Fondazione Mediterraneo continues its activities in the **2nd European Masters in Training** which includes "*Models of complexity and Human Ecology: Tools for Community Development*" aiming at training experts in the management of

communities in terms of programme planning, community mediation and action for solidarity and citizenship.

## **12 - Branches Activities**

### **A) ALGERI**

#### **LIBRARIES : RESOURCES FOR THE SHARING OF KNOWLEDGE**

THE FONDAZIONE MEDITERRANEO, together with the National Library of Algiers, will hold a series of activities aiming at developing an Algerian-European cooperation to promote and present Islamic art and culture in a new light. In particular, a catalogue of the publications in Arabic will be published and distributed in Western countries and training courses for librarian will be organized.

### **B) AMMAN**

#### **CONTEMPORARY ISLAMIC ART: EXHIBITIONS AND SHOWS**

The FONDAZIONE MEDITERRANEO together with its office in Amman, the **Jordan National Gallery of Fine Arts**, following the great success of the exhibition "*Breaking the Veils: Women Artists from the Islamic World*", will organize exhibitions, events and training activities for artists of the Islamic world.

### **C) BENEVENTO**

#### **FOOD SECURITY AND SUSTAINABLE DEVELOPMENT**

Since 2003 Villa dei Papi di Benevento (a branch office of the Fondazione) has been hosted MARSec Mediterranean Agency for Remote Sensing and Environmental Control): an integrated system for global monitoring of the environment. The FONDAZIONE MEDITERRANEO, together with **MARSec** will organize important activities as:

- The Biennial of the future of agriculture and nutrition.
- High formation programs on satellite technology for youth coming from the Mediterranean countries.
- Free services for Mediterranean countries linked to the FONDAZIONE MEDITERRANEO and related to the condition of the forests and the desertification of these countries' lands.

### **D) COSENZA**

#### **EURO-MEDITERRANEAN MEETING**

Since 2005 the FONDAZIONE MEDITERRANEO, together with the **FONDAZIONE EUROPA MEZZOGIORNO MEDITERRANEO**, organizes yearly the Euro-Mediterranean Meeting: a meeting-debate whose protagonists – institutional representatives and members of the civil and religious society – are committed in developing the Euro-Mediterranean dialogue.

### **E) LECCE**

#### **MUSIC AND CULTURE**

This office is situated in the Sigismondo Castromediano Museum and is partner of the **Istituto di Culture Mediterranee (Mediterranean Cultures Institute) of the Province of Lecce**. It organizes the artistic event of New Year's Day with the "Euro-Mediterranean Concert for dialogue between cultures". The office in Lecce is particularly active in creating artistic and cultural publications of great interest for experts in the Euro-Mediterranean area; among those publication is worth to mention "The picturesque Mediterranean" and the "Mirror of the Mediterranean Sea"

### **F) MARRAKECH**

#### **CHAIRE AVERROÈS**

The CHAIRE AVERROÈS it has arisen from the joined initiative of the FONDAZIONE MEDITERRANEO and the University of Cadi Ayyad in Marrakech. The Chaire Averroès was funded in 1998. In September 1999 it has signed an agreement with

UNESCO with which it was defined as "*Chaire Averroès–Chaire UNESCO of the Mediterranean Studies.*" In the next five years the Fondazione will contribute, thank to this activity, to spread ideas and knowledge in the Mediterranean. This will be possible through intercultural, cultural and scientific exchanges aiming at strengthening ties between the two shores.

#### **G) MURCIA**

##### **IMMIGRANTS INTEGRATION AND "EUROMEDCITY"**

On the 26th May 2006 a new seat of FONDAZIONE MEDITERRANEO was opened in Murcia, thanks to the Memorandum of Understanding signed with the Council of Murcia.

During the five-year period in which Murcia will lead the Euromedcity network, the goal will be to increase membership in the network among other cities with not more than 1 million residents and which are located in the Euro-Mediterranean area. It will do so organizing yearly an International Meeting called "Cities for tolerance" as well as activities concerning the integration of migratory flows

#### **H) SKOPJE**

##### **BALKANS: RESOURCE FOR EUROPE AND THE MEDITERRANEAN**

One of the first branches of the FONDAZIONE MEDITERRANEO is situated in the Macedonian Academy of Science and Arts. One of the activities carried out by this office is to realize an International Conference, to be held annually, on "Balkans: science and culture together for peace and development". It aims at integrating Balkans in the EU and in the Mediterranean.

### **13 - Activities of the Networks teamed with Fondazione Mediterraneo**

#### **A) EURO-MEDITERRANEAN FOUNDATION FOR THE DIALOGUE BETWEEN CULTURE "ANNA LINDH" (ALF)**

In 2005 Fondazione Mediterraneo (head of the Italian Network of the Anna Lindh Foundation), in order to support this new organism - according to the decision taken on occasion of the Euro-Mediterranean Conference held in Dublin in 2004 – has organized activities such as the *Conference on Classical Cultures* (12-14.11.2005, Naples) and the *Euro-Mediterranean Youth Workshop* (17-20.12.2005, Naples). In the next five years the Fondazione Mediterraneo and the Anna Lindh Foundation will carry out joined activities such as the awarding the "Euro-Mediterranean Prize for Dialogue between Cultures" and a series of workshops for the Euro-Mediterranean youth.

#### **B) EUROMED NGO PLATFORM**

Since 1995 Fondazione Mediterraneo has been playing an important role co-organizing and organizing 3 Euromed Civil Forums (1995, Barcelona; 1997, Naples; 2003, Naples). The Fondazione Mediterraneo, through the Euromed Civil Forum that took place in Naples on December 2003, has allowed the creation of this organization of which is founder member. Joined activities will be carried out.

#### **C) EUROMED YOUTH PLATFORM**

The Fondazione Mediterraneo has contributed in straightening this organization of which is member. Joined activities will be carried out.

#### **D) BIENNIAL OF YOUNG ARTISTS FROM EUROPE AND MEDITERRANEAN**

Since 1997 the Fondazione Mediterraneo has contributed in straightening this organization - of which is member – especially with the editions of Turin (1997) and Naples (2005). It is now collaborating in planning the 2007 edition in Alexandria.

#### **E) COPEAM**

Since 1999, FONDAZIONE MEDITERRANEO, together with the Mediterranean Academy, has been member of COPEAM. Considering the importance of

audiovisual material and information in the dialogue between cultures, the FONDAZIONE MEDITERRANEO supports goals and main activities of the COPEAM

F) IEM (INTERNATIONAL EUROPEAN MOVEMENT)

The FONDAZIONE MEDITERRANEO shares the IEM's goals, especially its program aimed at developing the Mediterranean. This program was drawn up on occasion of the Conference held in Algiers on the 24-26 February 2006. The FONDAZIONE MEDITERRANEO is both member of the IEM and of the "Comité de Suivi".

G) EUROMESCO

The FONDAZIONE MEDITERRANEO, through its series of seminars on "*International Policy in the Mediterranean*" joins the Euromesco activities based mainly on developing researches and establishing programmes agreed on by all of its members.

H) EURO-MEDITERRANEAN PARLIAMENTARY ASSEMBLY (EMPA)

Since 1997, the FONDAZIONE Mediterraneo has been collaborating to create a Euro-Mediterranean Parliamentary Assembly. The FM supported the EMPA from its establishment (December 2003, Naples); during the constitutional Assembly (March 2004, Athens) and the following Assemblies (2005, Rabat and 2006, Brussels.) Fondazione Mediterraneo will continue its collaboration with EMPA.

**Cinemamed** - The project, coordinated by the *Fondazione*, within the framework of "Euromed Audiovisual" (MEDA) Programme, has carried out a Travelling Mediterranean Cinema Festival, as well as high level training courses for professionals related to the cinema ("Aristote" Programme). It has organized 3 "Civil Forums Euromed" (1995 Barcelona; 1997 Naples; 2003 Naples) and has collaborated to other forums organized in other Euro-Mediterranean cities.

#### **1995 - Barcelona**

This Forum took place in Barcelona on 29th November until 1st December 1995. The Fondazione Mediterraneo collaborated with the Institut Català de la Mediterrània in the organization of the event. For the first time, 1500 qualified representatives of the Civil society, coming from Southern and Eastern Mediterranean Countries and from the European Union, met with the aim to institute a permanent platform for dialogue and cooperation. The Forum produced and studied ideas and concrete projects of fundamental importance for the Euro-Mediterranean association which has achieved a historical goal.

#### **1997 - Naples**

This Forum, was organised in Naples from 12<sup>th</sup>-14<sup>th</sup> December by the Fondazione Mediterraneo, under the High Patronage of the President of the Italian Republic, in collaboration with Regions, Cities, Institutions and NGOs. On this occasion, 2248 representatives of numerous bodies of the Euro-Mediterranean Civil Society, coming from 36 Countries, dealt with 4 thematic areas, divided into 11 Sessions, and produced 86 drafts for projects. The 2248 participants of the 2nd Euromed Civil Forum adopted a recommendation and asked the Fondazione Mediterraneo to create following structures:

- **Accademia del Mediterraneo:** a co-partnership of Euro-Mediterranean Academies and high level Cultural and Scientific Associations.
- **Euromedcity:** a co-partnership of Cities, Provinces, Regions, Local Communities and already existing networks of Cities, through which information, experiences and examples of good practice can be transmitted.
- **Isolamed:** a co-partnership of Euro-Mediterranean islands and already existing island networks through which information, experiences and examples of good practice can be transmitted.
- **Almamed:** a co-partnership of all Universities and University networks of the Euro-Mediterranean Countries.
- **Labmed:** Network of organisms and associations of the Civil Society

The Fondazione Mediterraneo has thereafter created these organisms and over 500 Euro-Mediterranean institutes have adhered to their statutes.

#### **2003 – Naples**

The Fondazione Mediterraneo wanted to realise this Euromed Civil Forum shortly before the 4<sup>th</sup> Euro-Mediterranean Conference would take place in Naples (2<sup>nd</sup> and 3<sup>rd</sup> December 2003).

The objective is to get closer to a renovated form of the Civil Forum. Actually before the execution of the Civil Forum, a democratic and open preparatory process between actors of civil society and public entities took place. A *projet de pilotage* representing the variety of an autonomous civil society was established and preparatory meetings took place especially on the southern shore of the Mediterranean. Thanks to this event and to the sustain of the Fondazione

Mediterraneo and a contribution by the European Commission it has become possible to form a “**Non-Governmental Platform**” during the Euromed Civil Forum in Luxemburg (1.-3.04.2005).

- The 1<sup>st</sup> European Advanced Training Programme: “Models of Complexity and Human Ecology: Tools for Community Development” (Naples 1998-2001), open to graduates in psychology fields to develop the empowerment and promotion of individual and group community resources.
- The 2<sup>nd</sup> European Advanced Training Programme “Models of Complexity and Human Ecology: Tools for Community Development” (Naples 2004-2005), aimed at training young people for social mediation and actions promoting participation, solidarity and citizenship. This programme is held in collaboration with local communities and civil society bodies.
- Accomplishment of an e-learning platform to support teaching and training activities using one of the most powerful and modern methods developed in the United States and used in universities and research centres in public and private education.

*To remember and thank a great poet for his teachings and his works, a man who showed us that literature in itself would not be enough: rather, peace and reciprocal respect must be promoted through concrete actions.*

## 14 - EURO-MEDITERRANEAN PROJECTS

The *Fondazione* has realised broad projects, both autonomously and in response to local and international calls for proposals, obtaining accolades upon their completion (for their quality, transparency, and follow-on results) in official evaluations of the co-funding institutions.
